  - General consensus was that it would be a good idea.
- Sharon Berry: Query re: Regional Directors. What is the length of term and procedure for electing?
  - Mary responded: Regional directors must be elected from at least three of the five regions of Canada as
    designated by the Canadian Kennel Club. The five regions are: Atlantic, Quebec, Ontario, Western Canada
    and British Columbia. Regional Directors must reside within the region they represent. They shall be elected by
    members in good standing in their own region in time for results to be announced at the Annual General
    Meeting.
  - So far Regional Directors have been static. From what I can see from the Constitution and By-:Laws you can nominate each year.
  - Be aware that all nominations must be sent by March 30<sup>th</sup>
  - Sharon Berry asked: If no nominations are forwarded, does that mean there is no director for that region or by default does it remain the same person
  - Lillian responded: historically if no nominations are rec'd .. the nomination. committee. contacts the incumbent and asks them if they will stand.
  - Sharon Berry: OK, but I don't think that is what has happened as I have not been asked for several years, not that I mind doing it. Just thought there should be a procedure and term
  - Tara Rioux: Do Regional Directors welcome new members and mentor them per se?
  - Several answered that yes that is part of their duties.
