



BOXER CLUB OF CANADA INC.

National Specialty Application Form (rev. 2019)

The Canadian Kennel Club has instituted policy that states National Breed Clubs must not hold their annual National Specialty in the same geographical region two years in succession. This rule does not apply if there are no applications from other regions.

In an effort to ensure the National Specialty is successful in whichever region it is held and to limit financial and civil liability on the part of The Boxer Club of Canada Inc. (BCCI), this 3 page application must be completed, in full, by the club(s) applying to hold the National Specialty **before** the request will be considered.

There are no fees associated with this application. The BCCI does not require payment of the per dog rebate fees.

In this application form, the term BCCI represents the Boxer Club of Canada Inc., and the term club represents the club making the application to hold the event.

The application form must be returned to the current Correspondence Secretary of the BCCI and, where indicated, must bear the original signatures of the persons shown on the form.

The application must be received by the BCCI Correspondence Secretary by the end of February, two full years in advance of the show date being requested (i.e. February 28, 2004 for the 2006 show). All applications received by the BCCI will be held until the end of February when a decision will be made.

An application to hold the BCCI National Specialty must be made by a club and the club must have at least one member of the BCCI on its membership rolls. The BCCI member must be a current member of the BCCI and his / her membership must be in good standing. As noted below, the Executive of the club applying to hold the event must sign this document indicating their club wishes to hold the National Specialty and they agree with the terms set out in the application.

The financial and civil liability of the BCCI shall be limited to the cost of the annual keeper (perpetual). All other costs associated with the show will be borne by the club holding the event.

Costs to be borne by the club holding the event include, but are not limited to, all fees payable to the CKC, site rental, judge's fees and expenses, trophies (with the exception of the annual keeper (perpetual) trophies, ribbons and rosettes, ring steward, show secretary, cleanup, premium list, insurance premiums, prizes and advertising.

Any profits resulting from the BCCI National Specialty will be retained by the club hosting the Specialty.

The club holding the BCCI National Specialty will provide, in writing, a full financial disclosure of the BCCI National Specialty, to the President of the BCCI within thirty (30) days of the event.

The club holding the Specialty will provide the President of the BCCI with a fully marked show catalogue within thirty (30) days of the event. The club holding the Specialty shall appoint a Show Chairperson for the event. The Show Chairperson may not show, either personally or through a third party, any Boxers owned by the Show Chairperson.

Cash prizes for the Sweepstakes shall come from the Sweepstake entry fees.

The BCCI National Specialty may be held as a stand-alone event or as part of an all breed show.

The Executive of the BCCI reserves the right to approve the judges for the BCCI National Specialty. The club applying for the BCCI National Specialty will complete and forward the original of all event date and associated forms to the Correspondence Secretary of the BCCI for signature at least six months in advance of the show date.
