New Business

- Jenny: We have just received this letter re: forming an Ontario Assoc of Recognized Kennel Clubs. Asking for our support in keeping the sport of purebred dogs alive.
 - On Tuesday, April 13, 2010 a meeting was held in Dorchester, Ontario to discuss the current state of our Canadian kennel Club. A well organized discussion proceeded and many good points, ideas and suggestions were presented by the members in attendance. As you are aware, the membership disagreed with the implementation of the \$3.00 Non-Members fee. A massive letter writing programme of protests ensued. The memberships voice was heard, the board rescinded the proposal at the AGM in Winnipeg. Since that annual meeting other concerns have presented themselves to us, the members. One of the suggestions discussed was the formation of an Ontario Association of CKC recognized Kennel Clubs . This was brought to light by the fact that other provinces have already formed provincial associations of kennel clubs to make sure their voices are heard, namely British Columbia and Alberta. To understand what such an Association would represent, we have outlined some objectives. 1) The Association would give the membership a united voice. 2) The Association would participate, with due diligence, in all aspects of the CKC (i.e. Policy, By-laws, procedures, Referendums, etc.) 3) The Association would monitor any legislative body that may wish impose change on purebred dogs (i.e. Government, Veterinarian Associations, Special interest groups, etc.) 4) The Association would represent a sounding board for the CKC and would work in concert with elected board members and staff to insure the membership is included in all aspects of our club. At this time, we are asking for your clubs support and involvement in the development of such an association. We ask that you take the concept to your membership. If your club is interested and would like to be included in the As If your club is interested and would like to be included in the Associations formation, we ask that you do the following. a) Fill out the attached membership form. b) Send a complete list of your club's CKC members in good standing. c) We would ask that you appoint a delegate and an alternate to represent your club at Association meetings in the future. We ask that your response be sent no later than MAY 30th, 2010. Also, if we have missed a club, we ask that you forward this letter to them. TAKE AN ACTIVE
